**IMPORTANT COMMUNICATION ON PDE DATES FOR 2024-2025 FINANCIAL YEAR**

This serves to advise stakeholders of the approved PDE dates for the financial year 2024/2025 which commences on the 1<sup>st</sup> of April 2024. **PDE scheduled for 09 February 2024 will proceed as scheduled followed by the following dates:**

<b>IMPORTANT CONSIDERATIONS/ DATES/PERIODS:</b>	<p><b>Professional Designation Examination ('PDE') registration or enrolment:</b></p> <ul style="list-style-type: none"><li>• PDE registration/enrolment is done strictly via MyPPRA Portal.</li><li>• No registration /enrolment forms (including those used in the past) will be issued to prospective PDE candidates for the purposes of enrolment or registration for the examination.</li><li>• No PDE registration/ enrolment submitted by the prospective PDE candidate will be regarded.</li><li>• Payment for PDE registration /enrolment must be made using the correct Reference number and by the closing date.</li><li>• No need to email payment proof to PPRA as this will reflect on the PPRA Bank statement.</li><li>• Property Practitioners must note that the PPRA links PDE payments to the PDE registration/ enrolment / booking made on the portal to generate an Exam Seat Number and allocate on the Property Practitioner's profile on the portal. This therefore means that the PPRA will not send seat numbers, but Property Practitioners must check for these by logging-in onto their profile on MyPPRA portal.</li><li>• Property practitioners may check their seat numbers at least from two weeks before the actual exam date.</li></ul> <p><b>Postponements:</b></p> <ul style="list-style-type: none"><li>• All exam postponement requests must be made in writing and accompanied with supporting reasons and documents. Such must be submitted at least 14 days before the exam date.</li></ul>	

	<ul style="list-style-type: none"> <li>• <b>No postponement made after this prescribed period will be accepted except for those arising from unforeseen circumstances and supported will be accepted.</b></li> </ul> <p><b>PDE Results and certificates:</b></p> <ul style="list-style-type: none"> <li>• PDE results are released at least eight (8) weeks after the actual exam date.</li> <li>• PDE Certificates for successful completion of PDE will be viewable on MyPPRA Portal once results have been released.</li> </ul> <p><b>Appeals against PDE results and Requests for the viewing of script:</b></p> <ul style="list-style-type: none"> <li>• All appeals and requests for script review must be submitted with proof of payments within 14 days of release of exam results.</li> <li>• <b>No late appeals or requests for the viewing of scripts received after this prescribed period will be accepted.</b></li> </ul>
